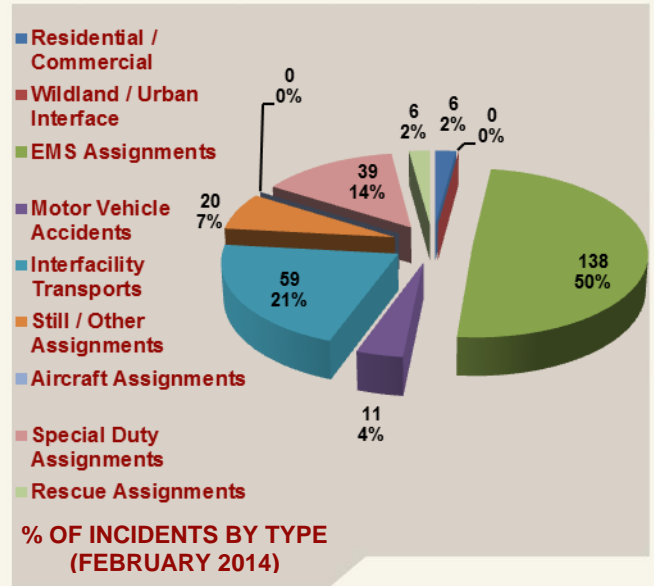
## SIGNIFICANT INCIDENTS / FIRES

**SATURDAY FEBRUARY 2, 2014 at approximately 12:40 AM:** Sedona Fire District responded to a reported fire on the exterior patio at the 100 block of Bristlecone Pines Road. On arrival, crews found the resident using a garden hose to suppress a fire at a built-in BBQ. The resident stated they had used the BBQ earlier that evening. The cause of the fire was in the improper installation of a natural gas BBQ. The BBQ was installed too close to combustible wood frame construction.

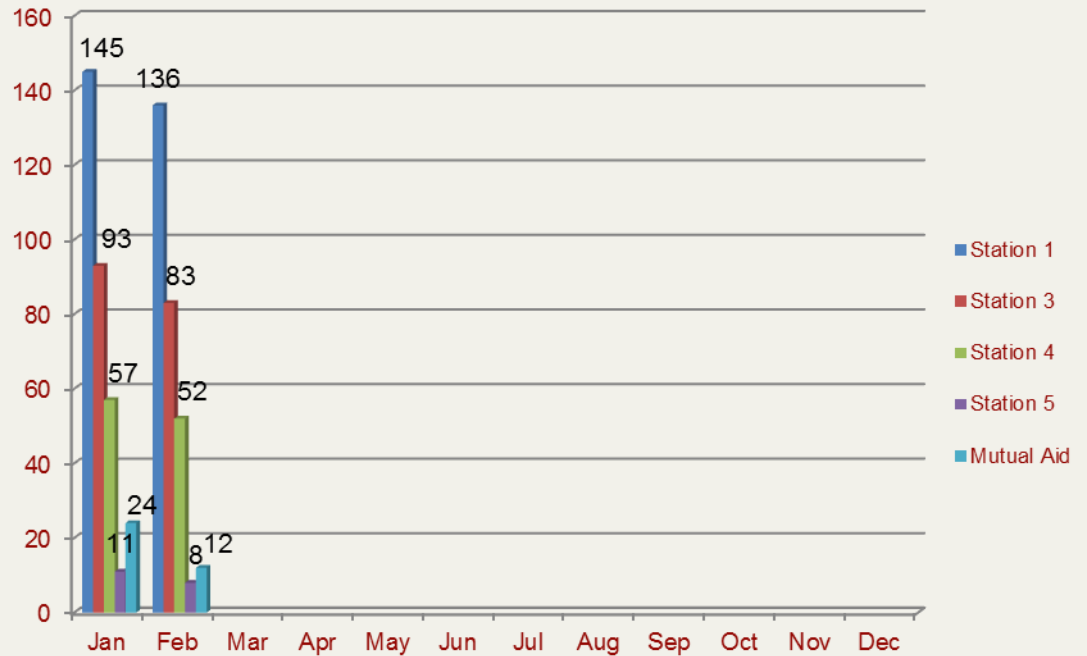

## TRAINING INFORMATION:

### Required Training:

- Firefighter Mark Beneitone presented the required OSHA Training Improving Chemical Facility Safety and Security to the members of the district.
- Reserve Firefighter Training was conducted on February 8, 9, 22, and 23 with five members participating.
- Engineers Jamie Ingrao and Rodrigo Sanchez conducted the Extrication and Stabilization Training.
- Training Division met with crews to cover training updates, class requests, secondary education, Firehouse reporting and SOPs.
- Members completed CEP and EMT refreshers.

### Conferences:

- CRM members Kevin Sullivan and Gary Johnson attended the Improvised Explosives Workshop sponsored by the FBI and Phoenix Police. Job pertinence: Fire investigation and code enforcement; effective identification of possible improved explosives that may be encountered in the field.
- Our EMS Committee attended the AZDHS Community Paramedicine; this meeting will enable the committee with the various EMS updates and program development.
