

SIGNIFICANT INCIDENTS / FIRES

JANUARY 21, 2014 at approximately 2:00 AM: SFD responded to a reported water flow alarm at a restaurant in the 1300 block of State Route 89A. On arrival crews found water flowing from an activated fire sprinkler head in the walk-in freezer. The cause of the sprinkler activation was a failure in the defrost cycle of the freezer. Once the refrigeration unit went into the defrost cycle, it failed to cycle back to normal operations. The heater continued to operate raising the internal temperature in the freezer until the fire sprinkler head activated. The freezer was empty at the time of the event.

JANUARY 21, 2014 at approximately 11:00 AM: SFD responded to a reported malfunctioning gas fireplace in the 100 block of Oak Creek Drive. On arrival, crews noticed a distinct smoke order throughout the home, which was in the process of being sold. Heat was noted in the area directly in front of and above the fireplace by using a Thermal Imaging Camera. The fireplace was a gas unit surrounded by a round drywall wall. Further investigation revealed the fireplace may have not been installed to the manufacturer's installation instructions.



TRAINING INFORMATION:

Required Training:

- Gary Johnson and Kevin Sullivan completed Arizona State Forestry Division FireWise Community Training to improve and enhance the Wildland risk assessments we conduct.
- Gary Johnson has completed his certification as a Fire Inspector II. This requirement is set forth in NFPA 1031, Standard for Professional Fire Inspector and Plan Examiner.

Conferences:

- Three SFD members attended the Arizona Fire District Association Conference. These conferences provide educational opportunities in all areas of District administration and guidelines in areas of legal and financial issues, human resources, and liability.
- Four members of SFD attended the Arizona Ambulance Association Conference. This conference helps with various EMS updates and program development.

Associates/Bachelor's Degree:

 Several members are working toward Associates and Bachelor's Degrees.

Certificates: SFD hosted the following classes in development of education and training through our "Train-the-Trainer" Program to build a group of specialized instructors to bring affordable training to our members and other fire departments.

- SFD in conjunction with Grand Canyon National Park and Northwest Fire
 District presented the Fire Line Medical Provider Course to address the essential skills for EMTs and CEPs to function effectively, and bring a greater awareness on wildland fires.
- The Incident Safety Officer Course was designed to equip new instructors with the appropriate and accurate knowledge to present this curriculum to their fire department.
- SFD instructors presented the Wildland S230 and S231 Courses. This course addressed the essential skills for firefighters to function in the CRWB and ENGB roles on wildland fires.

NOTE: This chart indicates average response times for various types of emergency calls in our district. Please note Rescue Assignments (such as injuries on trails, helicopter rescues, swiftwater assignments, etc.) and Wildland incidents which occur in the primary jurisdiction of the US Forest Service have been separated from other responses to more fairly represent SFD's emergency response times.
