



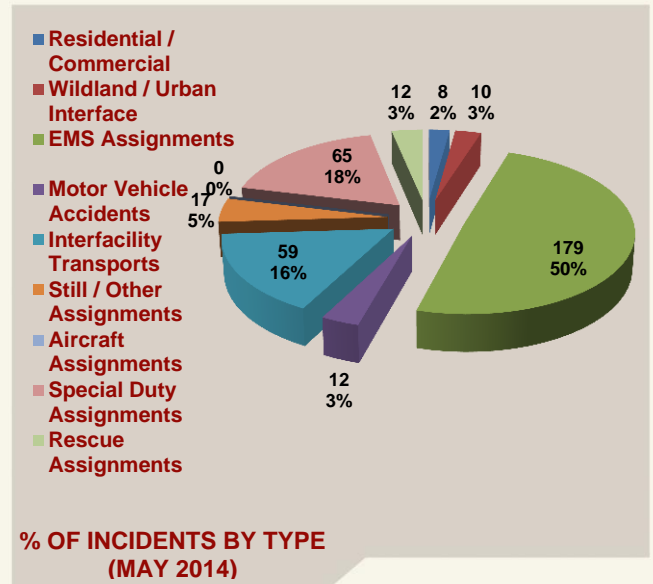
SEDONA FIRE DISTRICT FIRE CHIEF REPORT

MAY 2014

Presented to the Fire Board by Fire Chief Kris Kazian on June 25, 2014

SIGNIFICANT EVENTS (MAY 2014):

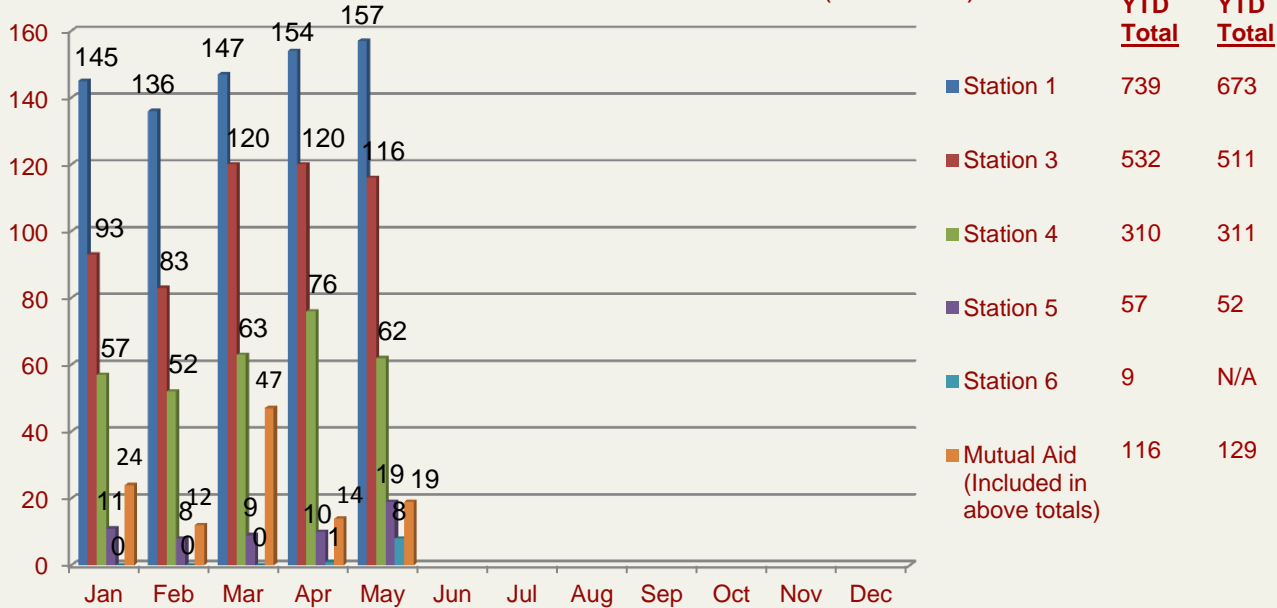
- **May 3, 2014 / 9:00 PM:** SFD crews responded to a reported kitchen fire at the Chocolate Tree located on West Hwy. 89A. Upon arrival, crews found the fire had been extinguished by an employee using a portable fire extinguisher. Fire investigation determined it was caused when an employee left the chocolate grinder on, which overheated and ignited the appliance's plastic housing. Damage was limited to smoke throughout the building, which does have an automatic fire sprinkler system. The employee extinguishing the fire with a fire extinguisher prevented the system activating.
- **May 19, 2014 / 9:00 AM:** Crews responded to a reported generator fire at the rear of the Safeway building near loading dock. Fire was contained to exterior of generator. Investigators determined it was caused when a cardboard box was placed over generator's exhaust pipe, causing the heat from exhaust to ignite cardboard.
- **May 20, 2014 / 3:45 PM:** Crews responded to a wildfire north of Slide Rock State Park in Oak Creek Canyon. SFD, a Type 1 Management Team, and Forest Service crews from all over the USA worked to suppress the fire. It was 100% contained on June 4, 2014 after consuming over 21,000 acres at an estimated cost of \$10.1 million. Mandatory evacuations were ordered for areas north of Slide Rock. Pre-evacuation orders were issued for communities of Kachina Village and Forest Highlands. Over 1,000 personnel were assigned to the fire. No structures or lives were lost.
