- 2. The application shall be submitted 10 business days in advance of the event date.
- 3. The application and floor plan will be reviewed and approved by Fire Prevention Inspection Staff. You will be notified if any additional information is required.

4. A site inspection will be required a minimum of 1.5 hours prior to the opening of the event and will include verification of exit signs and aisle widths, food truck inspections, under tent set up, fire extinguisher placement, and verification of any green tags issued for stages, bleachers, and generator by other agencies. Please call the office at 928.204.8926 to schedule. Normal business hours are Monday – Thursday from 7:00 am to 5:00pm. A permit will be issued when the inspection is completed and in compliance with the current Sedona Fire District Fire Code.
