Pursuant to notice, a regular meeting of the Sedona Fire District (SFD) Public Safety Personnel Retirement System (PSPRS) Local Board was called to order by Chairperson Helen McNeal at 3:04 PM on Thursday, December 4, 2025. A quorum was present and the meeting, having been duly convened, proceeded with business. Ms. McNeal led the Pledge of Allegiance.

2) MEMBERSHIP STATUS UPDATES

- a. New DROP entry, as of July 1, 2025: Division Chief Jordan Baker – Effective 10/24/2025

Keona Freeman, HR Manager, advised the Board that Division Chief (DC) Jordan Baker entered the DROP Program, effective October 24, 2025. Ms. Freeman congratulated DC Baker and acknowledged his service. She noted DC Baker will stay with SFD for another five years.

Ms. McNeal asked the Board if there were any questions or comments regarding the new hire applications and information. Mr. Eberlein, Member, commented that he reviewed the packet, noting that Kevin Ahlers and Brian Burke were already existing (PSPRS) members and Brandie Smith is a new addition to PSPRS.
